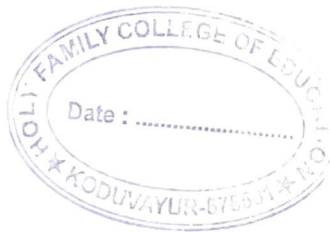

CLAUSE 1: CO-OPERATION

CLAUSE 2: VALIDITY

- Both parties may terminate this MoU upon 30 calendar days' notice in writing. In the event of termination, both the parties have to discharge their obligations.

CLAUSE 3: RELATIONSHIP BETWEEN THE PARTIES

- It is expressly agreed that **First Party** and **Second Party** are acting under this MoU as independent contractors, and the relationship established under this MoU shall not be constructed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party.
